Summer Street has a lot to celebrate this year as we mark our 50th anniversary. There was a time when opportunities were more limited for adults with intellectual disability. Change was set in motion in 1968 when a group of parents began what would become Summer Street. The Parkdale Activity Centre opened with 9 young adults and 1 staff person.

Today with 200 clients; over 30 staff; 2000 donors; thousands of customers; and a network of partners, Summer Street is a vibrant part of the community. We offer a full spectrum of programs and services to meet the diverse needs of our clients. "We're a person directed organization", says Director of Services, Dorothy Doyle "helping clients achieve a work life balance based upon personal interests and choices is our priority".

Many clients have been with Summer Street for years and some are now transitioning into retirement. Everyone has a different idea of when they would like to retire and what that means. In 2016 we introduced a retirement program that provides various options for our aging clients.



Over the years Summer Street has gone through a number of name changes that have usually reflected our philosophy or mission. It began with the The Parkdale Activity Centre. From there it became the Kinsmen Opportunity Centre, Summer Street Workshop and then Summer Street Industries. Today it's simply Summer Street, a name that suggests hope, optimism and a place in the community.



It all began in 1968 when a small group of parents got together and opened the Parkdale Activity Centre. Doors opened with 9 young adults and 1 staff person.

By the 70's along with other new programs, social enterprises were introduced. Baking, the wood shop and catering were the main initiatives.



In 1986 programs began to expand and life skills were introduced. Clients also learned to use public transportation increasing new access to employment.

Our vision

Summer Street was founded by a group of parents who wanted to create a better life for their sons and daughters. They could not have imagined how the organization would evolve or the extent of its impact. Consistent through the years has been a determination to challenge barriers and open doors.

Today we are driven by the desire for an equal playing field where everyone is treated with fairness and respect – including adults with intellectual disability. The idea of creating the most inclusive community imaginable may seem lofty or overly ambitious. We believe it is a realistic long-term vision and have made it part of our strategic planning. When you look back over the past 50 years it's not so hard to imagine. The generosity and will of the people of Pictou County are making it possible.

Today Summer Street provides 200 clients with a wide range of opportunities both in-house and throughout the community.



Summer Street Foundation was established in 1990. Since that time they have raised millions of dollars for new infrastructure and programming.

A major shift occurred in 2004 when a person-centred approach was adopted as the primary influencing philosophy for programs and services.

In 2008 the Client Council was established as a voice for clients. The group championed the first Bill of Rights and became spokespersons throughout the province.



Finding balance

Our direction comes from the people we serve. This means we meet the unique and diverse needs and desires of individuals as much as possible. Our spectrum of services take into account personal interests and varying degrees of ability and independence.

Although programs range from personal care and health to social skills and employment there is considerable interconnection. On any given day a client might participate in a day program, volunteer in the community and later work as an employee in one of our social enterprises. While this might meet the expectations of one client it could be out of the question for another. We are always working to provide a wide enough range of opportunities to include everyone.

As new skills are developed, levels of independence, desires and opportunities can change and new doors open. Our goal is to provide choices that help each client achieve a meaningful work life balance of their choosing. At the end of the day, all outcomes are measured by whether or not we have improved a client's quality of life.

In 2008 the mandate to respect the rights and abilities of everyone led to the creation of the Summer Street Client Council. The Council serves as a united voice for clients and ensures that staff, management and the Society Board understand their priorities.

Day Programs

Day programs enhance quality of life including education, literacy, health and well-being. Healthy lifestyles are promoted through individual and group counselling, fitness, nutrition, and personal health (emotional, sexual, self-esteem and relationships.)

Opportunities provide for social engagement and community volunteering.

Social Enterprises

Our Social Enterprises offer training and employment in a variety of business and service settings on-site and in the community. Each unit requires both basic and unique skill-sets and give clients the opportunity to discover what they enjoy doing and where they can excel.

Vocational Services Our vocational services offer training in work skills and work-related interpersonal skills, habits and attitudes required to be successful in any work setting. Our approach includes work place education, wellness and pre-employment experience (volunteering, career exploration, job sampling, job shadowing, mobile work crew and work stations).



Summer Street Works We assist in identifying career paths and providing support to clients. Together we explore interests and identify potential employers. One-on-one job site training and follow up may be included. We also help employers understand the many benefits of hiring adults with intellectual disability and provide ongoing support.

The Client Council was instrumental in developing a Bill of Rights. They meet annually with the Board to review and assess how successfully we are meeting the goals identified.



In 2016, over 50 people gathered at Summer Street to discuss evolving for the future. Participants from inside and outside the organization worked toward a relevant long-term vision.

The tone was set by the Client Council who shared emotional accounts of their lives. Stories of connection combined with the realities of alienation and barriers.

Topics covered education and training, inclusion, transportation and income issues. Working groups focused on key subjects and brainstormed ideas for moving forward. Results from the day became the foundation for a 3 year strategic plan.

Generosity

As everything has evolved at Summer Street so has the role of community. People donate time and expertise, monetary gifts, services and everything from cars to houses. Service clubs, especially the Kinsmen and UCT have been great friends and supporters on many levels.

Volunteer Board members meet regularly to provide governance, oversight and financial stewardship. Other volunteers share their time, skill and talents helping with activities and events.


Businesses and organizations are involved through employment and volunteer opportunities. In 2017 our clients wages exceeded \$700,000 and clients also spent over 14,500 hours volunteering. Community-based programs offer a sense of value, dignity and inclusion.




Foundation Funds Raised \$464,623



Catering Services

Summer Street offers exceptional catering both on and off-site.

Our customizable packages and large facilities are perfect for weddings, banquets, meetings and conferences. Our chef and team can prepare delicious appetizers for small groups or full course meals for special events.

Space Rentals

With over 6000 square feet of flexible, fully accessible space we can host anything from private meetings to large banquets. The main hall can be divided into four separate meeting areas accommodating from 20 to 400 people. Catering is provided with a seating capacity of 325 and available for lunches and coffee breaks.

30% of our annual revenue comes from social enterprise.

Quality Used Clothing (New Beginnings)

Our "gently worn" used clothing store offers quality clothing and accessories generously donated. Items are carefully selected and then given new life. Donations of gently worn clothing, outerwear, accessories and footwear are gratefully accepted.

Summer Street Works (Employment Services)

Our job developers meet with employers to discuss opportunities and good matches. Prior to placement, clients receive training in job skills, work related interpersonal skills, habits and attitudes for success in any work setting.

Client's have a wide range of skills including: production, customer support, food services, janitorial, inventory stocking and landscaping. Hiring is made easy with clearly established expectations and work terms. Ongoing support is provided as required. Employment can be fulltime, parttime or through subcontracting. The Summer Street Works program currently includes 60 employers.




Business Services We offer a variety of support services that can save businesses valuable staff time. Services include inserting; month-end mailing and other bulk or promotional mailing; packaging everything from educational materials to grocery products; and shredding services.





Foundation Donation to Summer Street Society \$430,000





Foundation Funds Raised in 2017 \$464,623




